OFFICIAL RULES

Or, you may enter by mail by sending your name, address, contact phone number, and email on a postcard (minimum size: 3.5 inches by 5 inches, and 0.016 inches thick) or 8 ½ inches by 11 inches sheet of paper and mailing your entry to Adventure Provision Company Summer Bingo 2024 Sweepstakes, 3787 Youree Dr, Shreveport, LA 71105.
